WHEREAS, the Entity is desirous that the contractor executes for the project: **FLOOD CONTROL PROJECT: DELOGGING OF CANALS/DESILTING OF RIVER (DIKING/UPGRADING OF RIVERBANKS ALONG DALAKITAN RIVER, SAN MATIAS, STO. TOMAS, PAMPANGA)** (hereinafter called "the Works") shall be completed within 30 C.D and the Entity has accepted the Bid for **TWO MILLION NINE HUNDRED NINETY-FIVE THOUSAND THREE HUNDRED THIRTY-SEVEN PESOS AND SIXTY-ONE CENTAVOS (2,995,337.61)**. remedying any defects therein.

5. Payment by the Entity to the Contractor shall be subject to a retention of Ten (10) percent of each approved payments to be released in accordance with section C1-06 of the Implementing Rules & Regulations.
