**CONTRACT FOR THE PROJECT: PURCHASE & DELIVERY OF TWO (2) UNIT
MINI DUMP TRUCK (4 CBM) FOR BARANGAY SAN MATIAS**

THIS AGREEMENT, made this 8th of September 2025 at Sto. Tomas, Pampanga, by and between the **BARANGAY SAN MATIAS** (herein after called the "Entity") of the two part and **UNITED ASIA AUTOMATIVE GROUP INC. (UAAGI)** (herein after called the "Supplier") of the other part.

WHEREAS, the Entity conducted a Public Bidding for the Purchase and Delivery of One (2) Unit Mini Dump Truck (4 CBM) for Barangay San Matias and has accepted the Single Calculated Bid by the Supplier for the Delivery of those goods for the Project: **Purchase & Delivery of Two (2) Unit Mini Dump Truck (4 CBM) for Barangay San Matias** in the sum of **Three Million Five Hundred Thousand (3,498,000.00) Pesos** (herein after called the "Contract Price")

NOW IN THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. In consideration of the sum of Three Million Five Hundred Thousand (3,498,000.00) Pesos or such other sums as may be ascertained, **UNITED ASIA AUTOMATIVE GROUP INC.**, agrees to deliver the goods for the Purchase & Deliver of Two (2) Unit Mini Dump Truck (4 CBM) for Barangay San Matias in accordance with his/her Bid.
3. The Municipality of Sto. Tomas, Pampanga, agrees to pay the above-mentioned sum in accordance with the Terms of the Contract.
