Prospective bidders must have an experience of having at least one (1) contract that is similar to the contract to bid, and whose value, adjusted to current price using the NSO consumer price indices, must be at least (50%) of the Approved Budget for the Contract (ABC).and have key personnel and equipment available for the prosecution of contract.

Bidding will be conducted through competitive bidding procedures using non – discretionary pass/fail criteria as specified in the implementing Rules and Regulations (IRR) of the Republic Act 9184 (RA 9184) otherwise known as the: Government procurement Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the BAC Secretariat and inspect the Bidding Document at the address below from 8:00 am to 5:00 pm.

The Bid Documents/Forms will be made available at the BAC Secretariat, Municipality of Sto. Tomas upon payment of non-refundable amount of P 5,000.00 to the Treasurer’s Cashier.

All bids must be accompanied by the bid security in any of the acceptable forms and in the amount stated in the ITB clause 18.

Bids will be opened in the presence of the bidder’s representatives who choose to attend at the address stated above. Late bids shall not be accepted.

The Municipality of Sto. Tomas reserves the right to reject any or all bids, and accept the offer most advantageous to the Government. The LGU Sto. Tomas assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
