**CONTRACT FOR THE PROJECT: PURCHASE AND DELIVERY OF  
MOTORIZED BANCA**

THIS AGREEMENT, made this 5<sup>th</sup> DAY OF SEPTEMBER 2025 at Sto. Tomas, Pampanga, by and between the MUNICIPALITY OF STO. TOMAS, PAMPANGA (herein after called the "Entity") of the one part and DAPER CONSTRUCTION & TRADING (hereinafter called the "Supplier") of the other part.

WHEREAS, the Entity conducted a Public Bidding for the Supply & Delivery of Motorized Banca and has accepted the Lowest Calculated Bid by the Supplier for the Delivery of those goods for the Project: **PURCHASE AND DELIVERY OF MOTORIZED BANCA** in the sum of **Two Million Nine Hundred Ninety-Three Thousand Seven Hundred Thirty PESOS (2,993,730.00)** (herein after called the "Contract Price") shall be completed within 45 C.D.

**NOW IN THIS AGREEMENT WITNESSETH AS FOLLOWS :**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. In consideration of the sum of **Two Million Nine Hundred Ninety-Three Thousand Seven Hundred Thirty Pesos (2,993,730.00)** or such other sums as may be ascertained, **Daper Construction & Trading**, agrees to deliver the goods for the Purchase and Delivery of Motorized Banca in accordance with his/her Bid.
3. The Municipality of Sto. Tomas, Pampanga, agrees to pay the above-mentioned sum in accordance with the Terms of the Contract.

IN THE WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines the day and year first before written.
