LOUR ANTHONY T. ORDOÑEZ of LATO BUILDERS, a company duly organized and existing under the laws of Philippines, with principal office at **San Nicolas, Sta. Rita Pampanga** hereinafter called "Contractor".

WHEREAS, the Entity invited Bids for certain works, particularly **FLOOD CONTROL PROGRAMS: UPGRADING OF PROTECTOVE DIKES AT BONDOC VILLE, STO. NIÑO(SAPA), STO. TOMAS, PAMPANGA**;

WHEREAS, the Contractor submitted a responsive bid and was awarded the contract for the procurement in the total amount of **One Million Eight Hundred Thousand Pesos (Php1,800,000.00)** hereinafter referred to as the "Contract Price."

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz.:
 - a. Philippine Bidding Documents (PBD);
 - *For Procurement of Infrastructure Projects*
 - i. Drawings/Plans;
 - ii. Scope of Work;
 - iii. Invitation to Bid;
 - iv. Instructions to Bidders;
 - v. Bid Data Sheet;
 - vi. Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - vii. Bill of Quantities;
 - viii. General and Special Conditions of Contract;
 - ix. Supplemental Bid Bulletins, if any; and

 - d. Notice of Award of Contract; and the Bidder's Conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.
3. In consideration of the Contract Price of **One Million Eight Hundred Thousand Pesos (Php1,800,000.00)** or such other sums as may be determined in accordance with the terms of the Contract, the Contractor agrees to deliver and perform the items and related services for the **FLOOD CONTROL PROGRAMS: UPGRADING OF PROTECTIVE DIKES AT BONDOC VILLE, STO. NIÑO(SAPA), STO. TOMAS, PAMPANGA**, described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
 4. The **MUNICIPALITY OF STO. TOMAS** agrees to pay the above-mentioned sum to the Contractor in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
 5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
